TUITION AND WITHDRAWAL POLICY CONTRACT 2021-2022

## Tuition Policy:

The Tuition rates for the 2021-2022 school year are as follows:

### Infants/Tiny Tots

Tuesday/Thursday (**2 days a week**) \$310.70/month

Monday/Wednesday/Friday (**3 days a week**)  
\$416.52/month

Monday-Friday (**5 days a week**) \$682.50/month

### Toddlers-Fours

Tuesday/Thursday (**2 days a week**) \$262.90/month

Monday/Wednesday/Friday (**3 days a week**)  
\$352.44/month

Monday-Friday (**5 days a week**) \$577.50/month

### Pre-K

\$370.00/month (**7:00am – 11:15am Monday-Friday**)

Extended Care \$13.75/day

Registration Fee: \$35.00 Supply Fee: \$50.00

### After School Care

Tuesday/Thursday (**2 days a week**) \$100.27/month

Monday/Wednesday/Friday (**3 days a week**)  
\$139.66/month

Monday-Friday (**5 days a week**) \$206.80/month

Tuition payments are due on the first of each month. A late charge of \$25.00 will be assessed for tuition not paid by the 15<sup>th</sup> of each month. If your account is not paid by the 15<sup>th</sup>,

please call the office, and speak with the Financial Manager Kim to prevent your child's enrollment from being terminated.

**Tuition is paid based on the number of days your child is scheduled to attend. No refund is given for an absence as per the Parent Handbook under vacation policy.**

**Late pick-up fees:**

Please pick up your child promptly at their scheduled pick-up time. Pick up time is 6:00pm, if you are later than 6:05pm we will charge your account \$1.00 per minute. If your child is still here after 6:05pm, the parent will be contacted by the person in charge. Chronic late pick up may result in dismissal. (Please inform the director if you are running late.)

**Drop-in Rate:** The new daily drop-in rate across the board for all ages will be \$35.00/day.

**WITHDRAWAL POLICY:**

In order to withdraw your child from our Early Learning Day School, you must in writing inform the Director thirty (30) days in advance. Please indicate in writing the last day that your child will attend our program. Once you have given written notice, you will still be responsible for the current month's tuition and your child will be considered enrolled and should attend our program for thirty (30) daytime period.
